


A time when generosity fills the air with hope

10 ways to make generosity a family tradition

As the world seems to grow more and more unpredictable, you may be looking for ways to bring a constant sense of God's peace and presence to your family. During the holiday season and beyond, family giving traditions can be a powerful way to find comfort in the chaos, connect with your community, and pass along your values. This year, we encourage you to start a new tradition with one of these activities, or use them to spark some ideas of your own.



1. BIG TIP TUESDAY: Every Tuesday, take your family out for a meal and leave an extravagant tip for your server. Let a different family member decide the amount every time, and whether it should be anonymous.

2. KID'S SHOPPING SPREE IN REVERSE:

Take young children to shop (on a budget) for gifts to donate to kids in need. They'll experience what it feels like to pick out a toy that's not for them and they'll learn what things cost.

3. YES! DAY: Pick one (or several) days throughout the season when you say "yes" to every charitable request you receive, even if it's just a small gift, prayer, or volunteer commitment.

4. YEAR-END GIVING REVIEW: Run reports from your Giving Fund to see when, where, and what you gave this year so far. Share with your family to celebrate your impact or decide what you'd like to do differently.

5. CHRISTMAS CARDS FOR STRANGERS:

Instead of (or in addition to) sending cards to friends and family, buy a box of Christmas cards and write an encouraging message or verse to share with people you meet during your day.

6. THE GIVING PENNIES GAME: Use your Giving Fund to research charities as a family. Give each child 10 pennies, representing \$100 each (or an amount of your choosing), to vote for their favorite ones. Then, log back into the Fund with your kids to make grants together.

7. THE LOVE LANGUAGE GIFT: Make sure each person in your family receives a gift in their special love language. If you're not sure what their love language is, go through the *The 5 Love Languages* with them to find out.

8. SERVING DAYS (INSTEAD OF SHOPPING DAYS): Count how many days there are until Christmas and see how many volunteer opportunities you can plan as a family so you spend more time serving and less time shopping.

9. PRIVILEGE MEETS RESPONSIBILITY:

Honor the teenagers in your life with the gift of a new privilege to enjoy in the coming year, and pair it with a new responsibility that involves giving back. **10.** THE JOY JAR: Encourage everyone to jot down their favorite moments of generosity this season and drop them in the Joy Jar. Keep it going all year long and read them all next Christmas Eve.



2021 year-end giving dates to remember

There's no better time than now to start planning your end-of-year giving.

Nov 15: Supporting Organizations

All requests for the creation of a new Supporting Organization must be made by this date.

Nov 29: Real Estate Gifts

Any real estate gifts requiring an environmental assessment must be initiated with NCF by this date.

Dec 10: Proprietary Mutual Funds

All proprietary mutual fund transfers must be initiated by this date.

Dec 15: Grants to Charities

Grant requests to approved charities must be submitted by this date if you would like a check mailed by the end of the year. Note: Grants do not have to be issued by year-end for tax purposes.

Dec 15: Publicly Traded Securities or E-checks

All stock and mutual fund transfers should be initiated with the transferring broker by this date. E-checks also need to be initiated by this date. A physical check or a wire transfer should be considered instead of an E-check after December 15.

Dec 15: Complex Gifts (business interests, real estate, and life insurance)

To ensure your complex gift can be completed by December 31, a completed Asset Donation Form and all accompanying required documents must be received by this date. Note: Due to the high volume of complex gifts at the end of the year, we encourage you to submit your documents as soon as possible. We can accept your gift as early as today with an effective date of December 31, 2021.

Dec 31: Cash and Complex Contributions

Physical checks and cash must be postmarked by this date. Wire transfers must be received in NCF's bank account by this date. Complex gifts must be finalized by this date.

Your last chance for 100% AGI Giving

The CARES ACT provision that allows you to deduct up to 100 percent of your adjusted gross income (AGI) with potential tax savings has been extended. There are a number of ways to reach 100% AGI, and we can show you how to get there.
